**REPAIR WELL PROCEDURE**

1. TOOH with the 2-3/8" production tbg.
2. TIH with bit and scraper for 5-1/2" csg to 7500'. .
3. Wireline set a CIBP at 7456'.
4. Cap the CIBP with 10' of sand/barite mixture. Bring the mixture up to 7440'. The mixture should be 33% barite and 67% 20/40 sand.
5. TIH with muleshoe, SN, and 2-3/8" tbg and land intake at 7400'. Check with Ralph Montoya before running the tbg in the well. Ralph may want to run 2-1/16" tbg rather than the 2-3/8" tbg.
6. Swab the well in and RTP.
