We are requesting permission to lay a temporary gas line to produce the subject well. The line will be 2-7/8" J55 tubing laid within 5-10 feet of the lease access roads to the Lindrith "B" Unit Well #25. Normal line pressure will be approximately 150 psi, and the maximum line pressure will be 250 psi. See the attached map for the layout of the gas line.
