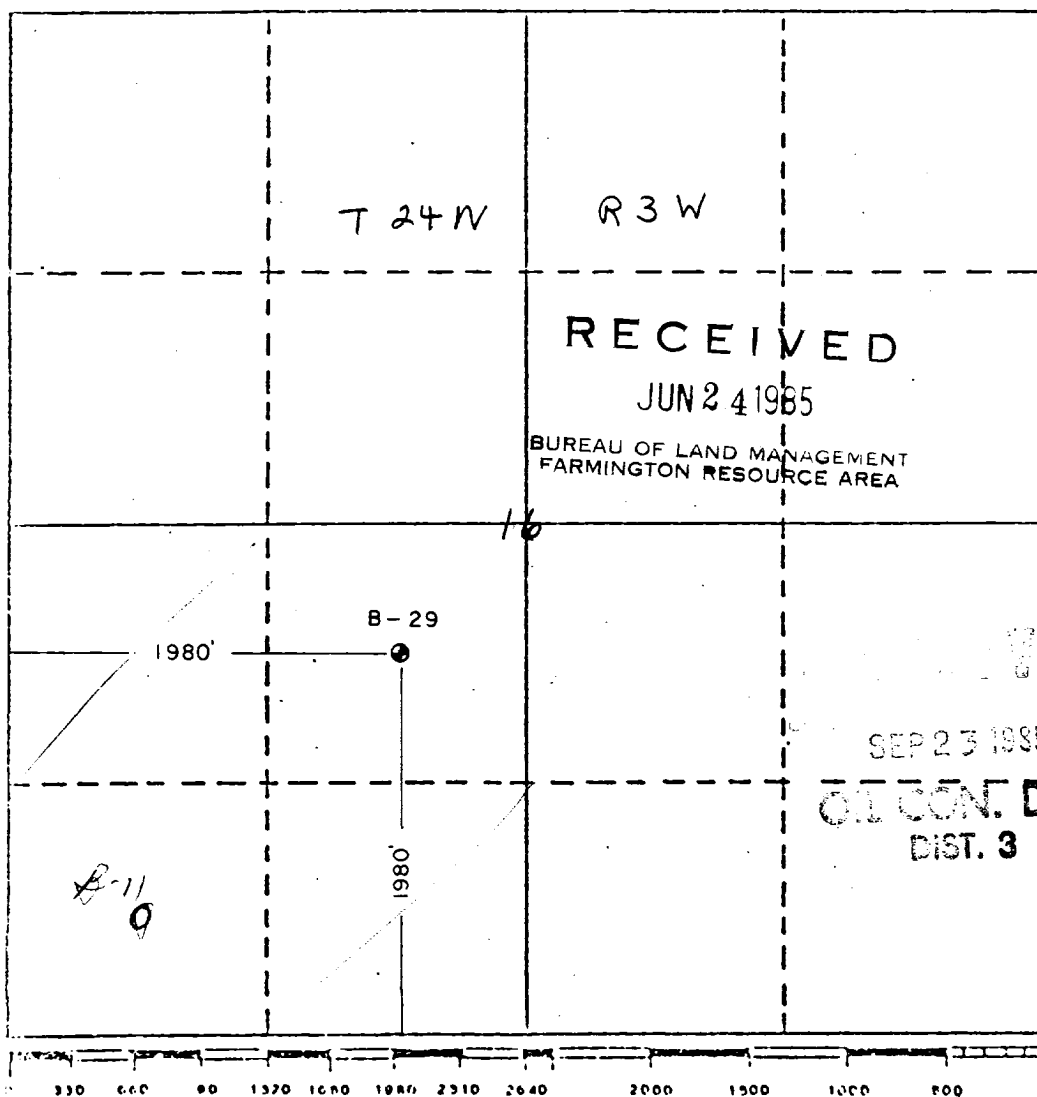

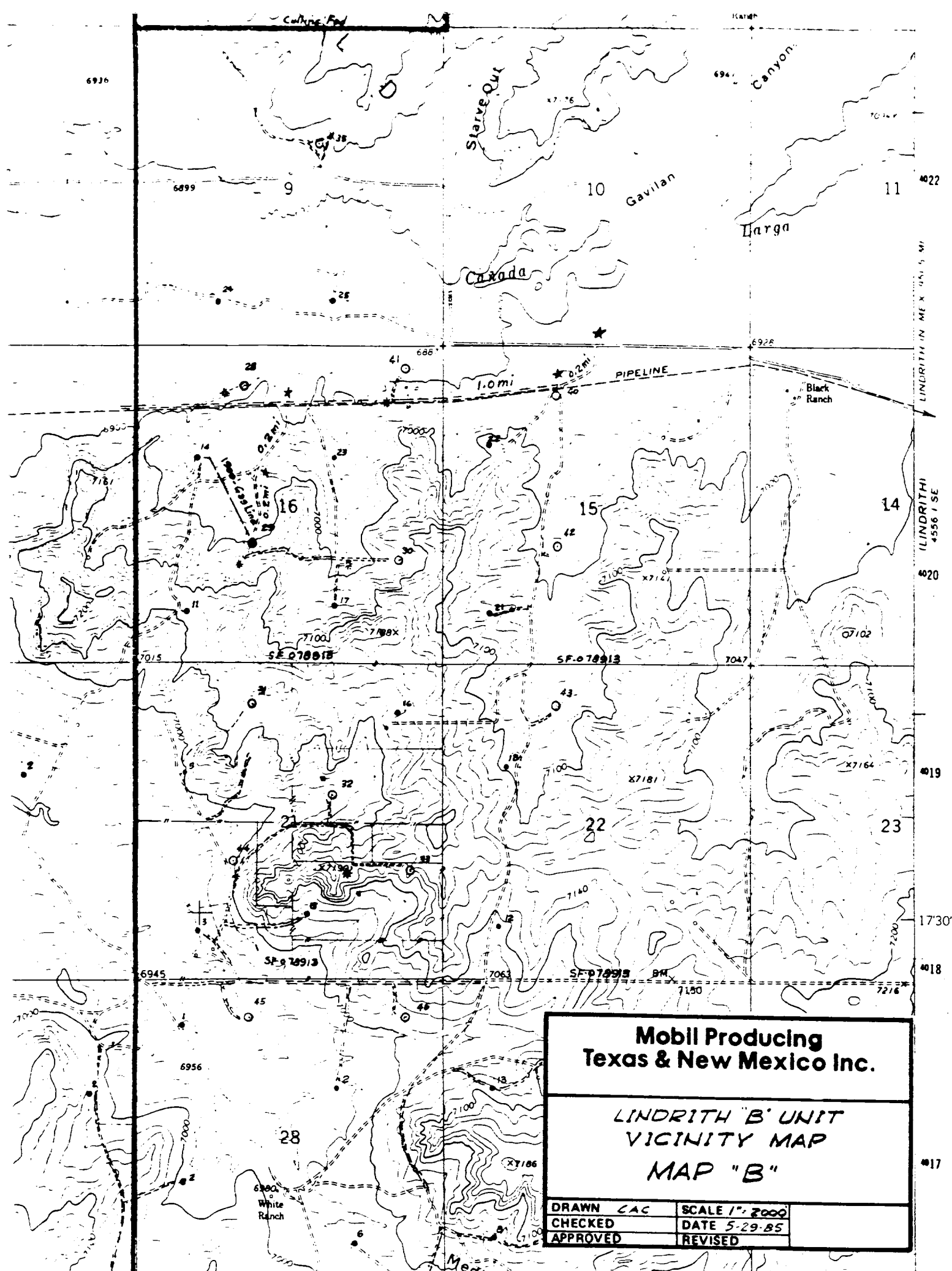

1. 240 Cu. Ft. Class B + ^{2%}CaCl₂ circulated to surface.
2. (a) 1st stage - 410 Cu. Ft. of Class B + Pacesetter lite circulated to 6000' where DV tool is set.
3. (b) 2nd stage - 1360 Cu. Ft. of Class B circulated from 6000' at DV tool to surface.
