Union Texas Petroleum wishes to advise that a 8-3/4" hole was drilled to 4175' KB. Run 7", 23#, K-55 casing to 4174' KB, cementing with 290 sxs (832 cu.ft.) 65/35 POZ containing 12% gel and 12-1/4# gilsonite/sk, tailed by 100 sxs (118 cu.ft.) C1 "B" with 2% CaCl2. Lost circulation during cementing Temperature survey run 11/13/86 shows cement top at 2800'. Drill 6-1/4# hole with gas to 6120' KB. Run 4-1/2", 10.5#, K-55 production liner from 3913'-6120' KB. Cement with 290 sxs (455 cu.ft.) POZ containing 4% gel, 6-1/4# gilsonite/sk and 10# salt/sk. Did not circulate cement. Perforate 2 holes at 5900'. Squeeze with 100 sxs (118 cu.ft.) C1 "B". Squeeze to 1000 psi. Cement top at 5884' KB by bond log run 12/11/86.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
