Due to excessive water production, it is intended to squeeze cement the Cliff House and Menefee as follows:

1. MIRU. TOH. Set RBP at 5820'.
2. TIH with packer set at 5100'. Squeeze cement perfs 5342 - 5790' with 150 sks cement. WOC.
3. TOH. TIH with bit. Drill out squeeze cement. Test casing to 500 psi. TOH.
4. TIH and retrieve RBP. TOH.
5. TIH and land tubing at 6050'. Swab well in. Return to production.
