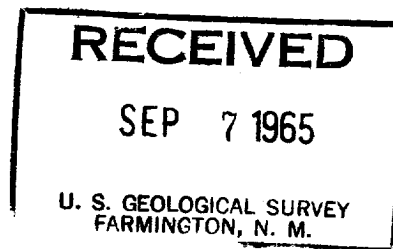

8-27-65 TD 6653' RKB. Ran 25 joints 789' 5-1/2" OD 17# N-80 casing for liner with left-hand thread backoff nipple on top of Joint #25. Landed with 202 joints 5-1/2" OD 15.5# J-55 casing. Liner set at 6598'. Cemented with 100 sacks regular cement, 12# Gilsomite per sack, 1# floccle per sack. Backed off 5-1/2" OD 15.5# J-55 casing. Laid down. Top of liner 5810', bottom 6598'.

8-28-65 Temperature survey showed top of cement at 5820'. Pressured up to 2100#. In 2 hours pressure dropped to 2050#.
