**DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED**

Perforated point look out zone at 4126-35 with 4 shots per foot. Swab tested  $\frac{3}{4}$  bbl fluid per hr.-85% water. Squeezed perforations with 60 sac cement and reperforated 4115-16 and 4118-22. After mud acid treatment, swabbed 1.86 bbls oil per hr. No water. Made 2 unsuccessful attempts to Frac. Equipped to POC the first 24 hrs, ending 1-31-57, pumped 108 bbls oil, no water.
