Dear Mr. Reynolds:

This letter shall serve as your authority to run 207 barrels of oil from your Paquenche A #3 well located C-10-24N-8W, Dufers Point Gallup-Dakota Pool, and 152 barrels of oil from your Ake #1 well located I-11-24N-8W, Escrito Gallup Pool to prevent possible loss by theft, vandalism or other causes.

Seals will be placed on the wellhead and tank valves to ensure that the wells remain shut-in until further notice by the Oil Conservation Division. Breakage of the seals shall constitute violation of the previously issued shut-in order and will subject the operator to the penalties as provided in the New Mexico Statutes Annotated, 1953 Compilation, Chapter 65 which says in part:

"65-3-27. PENALTIES FOR VIOLATIONS

B. Any person who knowingly and willfully violates any provision of this act or any rule, regulation or order of the commission or division made hereunder, shall, in the event a penalty for such violation is not otherwise provided for herein, be subject to a penalty of not to exceed one thousand dollars (\$1000) a day for each and every day of such violation, and for each and every act of violation, ..."

Thriftway Company is notified by copy of this letter for the authority to haul the products.
