DETAILS OF WORK

Subject well was drilled to a TD of 5580'. 5 1/2" casing was cemented at that point with 300 sacks cement. After 30 hours the pipe was tested okay with 1500 psi for 30 minutes. The hole was then displaced with oil and 500 gallons of acid was spotted on bottom. The casing was perforated with 4 jet shots per foot; intervals were 5410 - 12 and 5432 - 16. The well was then fraced with 20,000 gallons oil and 20,000 lbs sand. The average rate was 36 BPM at 2175 psi. Frac sand was cleaned out and the well was then placed on production.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
