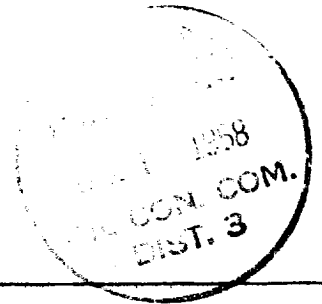

State of New Mexico "AV" Well No. 1 was spudded on November 24, 1958, and on November 25, 1958 8-5/8" casing was set at 197' with 160 sacks of cement. After waiting on cement, casing and water shut-off were tested with 400 pounds pressure for thirty minutes, which held with no drop in pressure. Reduced hole to 7-7/8" at 197 feet and resumed drilling operations.
