MI&RU Wayne Smith Drilling. Spudded 9-1/8" hole at 1000 hrs 8/10/96. Drilled 0-130'. Circulate hole. TOH. TIH with 3 jts. 7" 23# U-55 casing landed at 120'. Pump 5 bbls water. Cement with 50 sx class "B" cement (59 cu.ft.). Displace with 4 bbls water. Circulate 1 bbl cement. Plug down at 1445 hrs.

Nipple up BOP. Pressure test to 600#.
