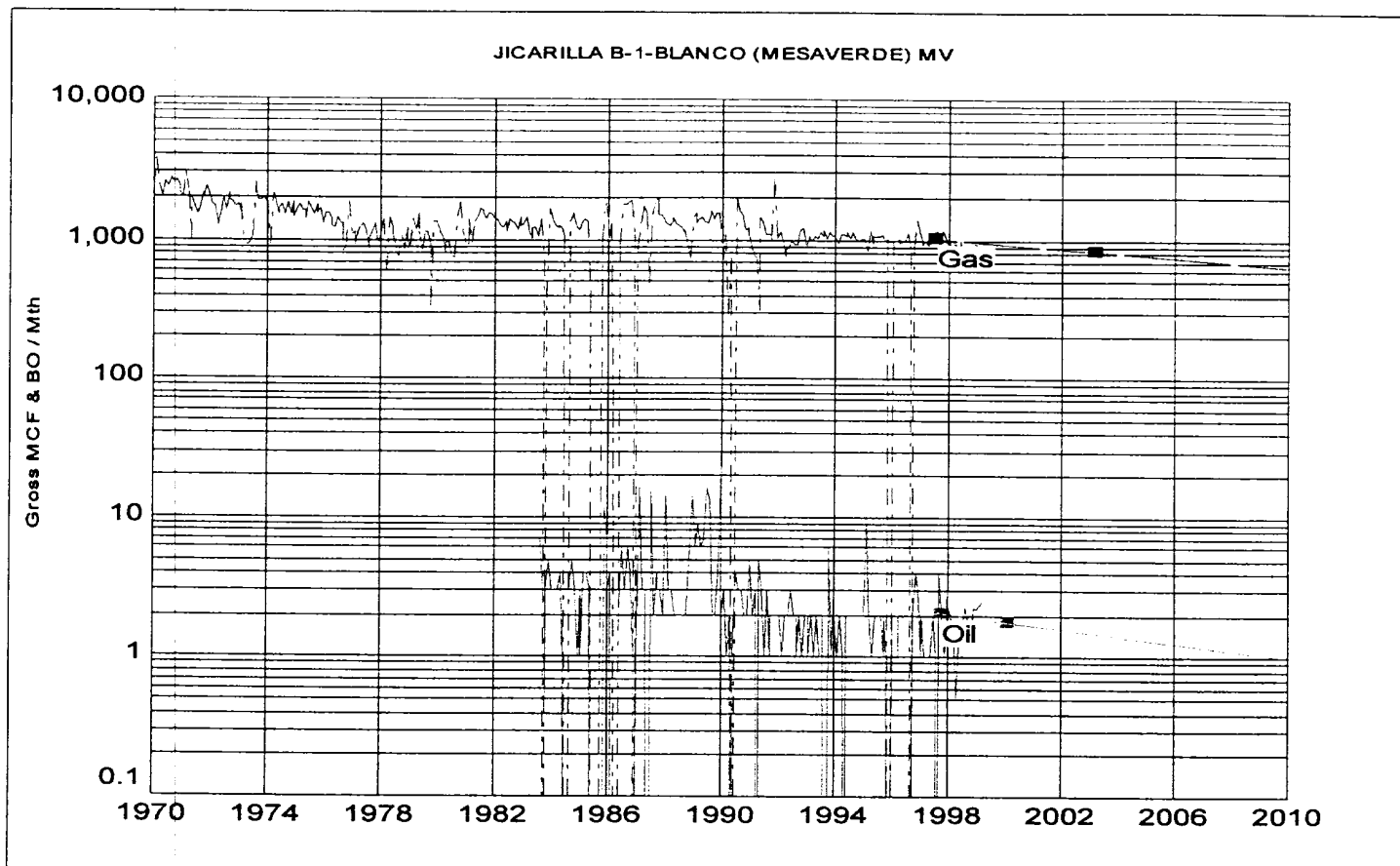

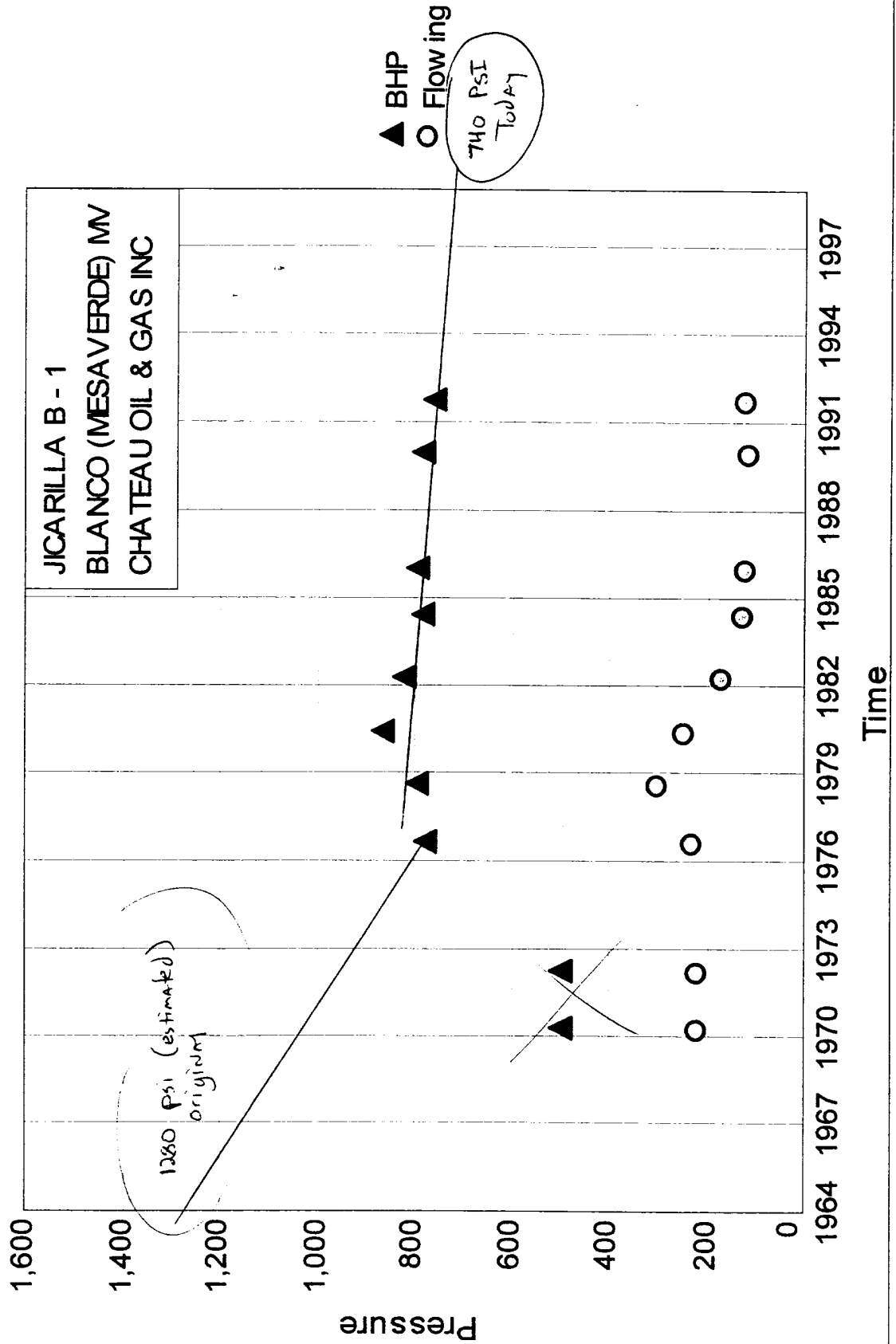
Pressure/Time Graph

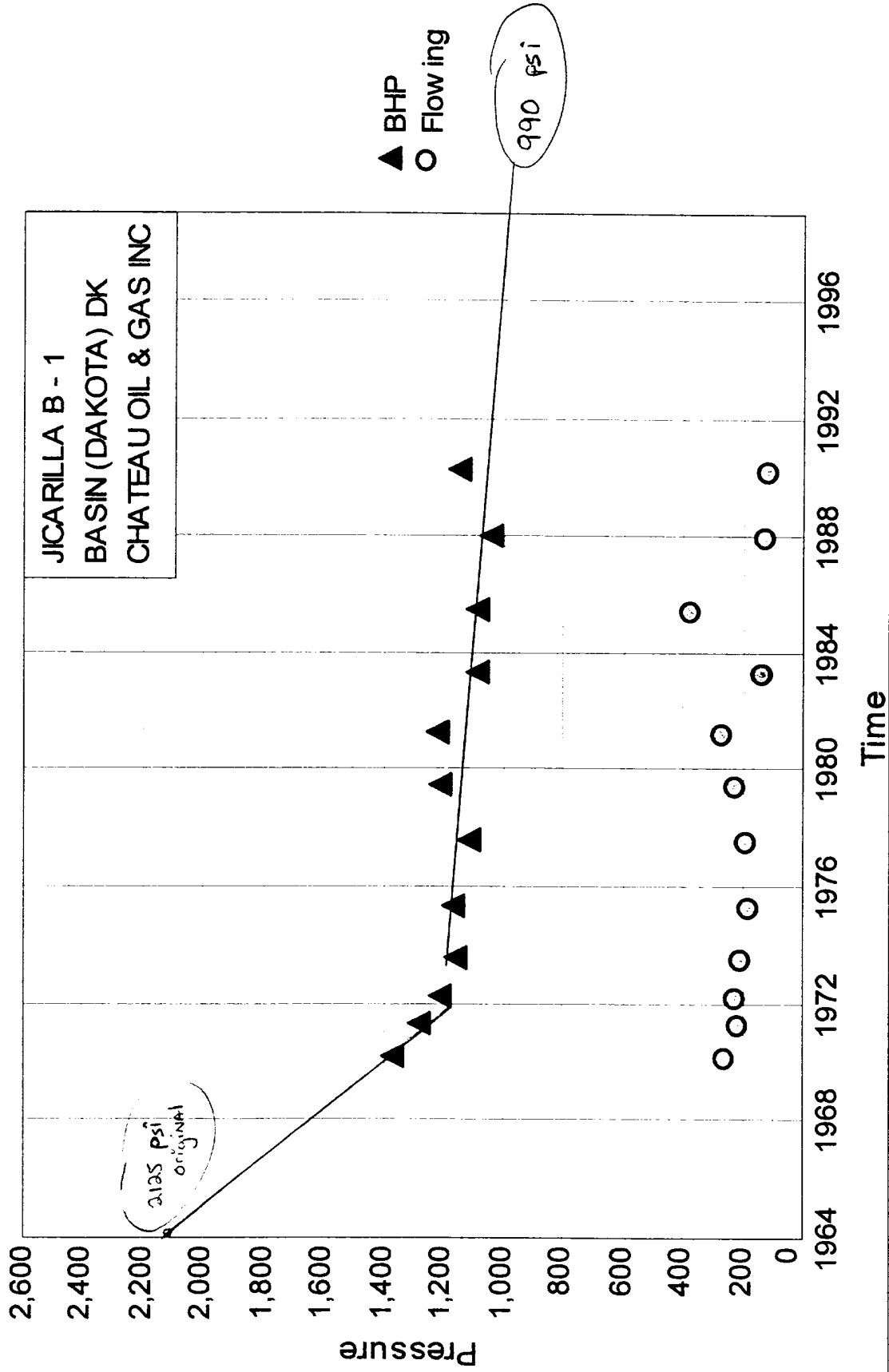
Pressure/Time Graph
