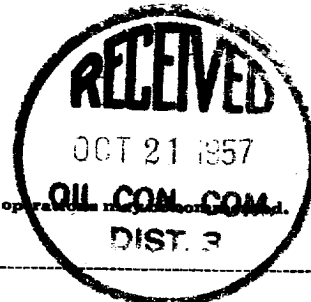

DETAILS OF WORK

9-20-57 TD 3217'. Cleaned out to 3190'. Perforated 3115-40' and 3140-72' with 4 shots per foot. Sandfraced with 25,000 gallons water and 30,000# sand, flushed with 3,000 gallons water. Breakdown pressure 2400#, treating pressure 1500-1750#. Dropped 110 rubber balls halfway through treatment. Average injection rate 58.4 barrels per minute.

9-21-57 After 13 hours flowing 2,459 MCF/day.
