ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on March 23, 1960, at Santa Fe, New Mexico, before Elvis A. Utz, Examiner duly appointed by the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission," in accordance with Rule 1214 of the Commission Rules and Regulations.

NOW, on this 8th day of April, 1960, the Commission, a quorum being present, having considered the application, the evidence adduced, and the recommendations of the Examiner, Elvis A. Utz, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That the applicant, Caulkins Oil Company, is the owner and operator of the Sanchez Well No. 1, located 560 feet from the North line and 660 feet from the West line of Section 24, Township 26 North, Range 6 West, NMHM, Rio Arriba County, New Mexico.

(3) That the applicant proposes to dually complete the said Sanchez Well No. 1 in such a manner as to permit the production of gas from the South Blanco-Pictured Cliffs Pool and the production of gas from the Dakota Producing Interval through parallel strings of tubing.

(4) That the applicant further seeks approval of the unorthodox location of said Sanchez Well No. 1 in the South Blanco-Pictured Cliffs Pool and in the Dakota Producing Interval.

(6) That the application should be approved.

IT IS THEREFORE ORDERED:

(1) That an unorthodox gas well location in the South Blanco-Pictured Cliffs Pool and in the Dakota Producing Interval be and the same is hereby approved for the Sanchez Well No. 1, located 560 feet from the North line and 660 feet from the West line of Section 24, Township 26 North, Range 6 West, San Miguel County, New Mexico.

(2) That the applicant, he and the same is hereby authorized to dually complete the said Sanchez Well No. 1 in such a manner as to permit the production of gas from the South Blanco-Pictured Cliffs Pool and the production of gas from the Dakota Producing Interval through parallel strings of tubing.

PROVIDED FURTHER, That the 5-1/2 inch liner shall be cemented from 7795 feet to 3300 feet or the base of the Menefee formation, and provided also, that the said 5-1/2 inch liner shall be cemented opposite the Pictured Cliffs formation in the interval from 2900 feet to 3300 feet.

PROVIDED FURTHER, That applicant shall complete, operate, and produce said well in accordance with the provisions of Section V, Rule 112-A.

PROVIDED FURTHER, That applicant shall take packer-leakage tests upon completion and annually thereafter during the Annual Deliverability Test Period for the South Blanco-Pictured Cliffs Pool.

IT IS FURTHER ORDERED:

That jurisdiction of this cause is hereby retained by the Commission for such further order or orders as may seem necessary or convenient for the prevention of waste and/or protection of correlative rights; upon failure of applicant to comply with any requirements of this order, the Commission may terminate the authority hereby granted and require applicant or its successors
