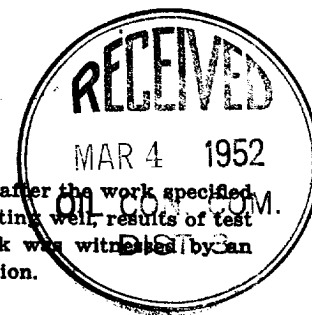


NEW MEXICO OIL CONSERVATION COMMISSION

Moved in cable tools and drilled cement plug. Let hole set for 3 hours and run bailer test. No water. Casing O.K. Cleaned out to TD 3125'. Gas measured 35 MCF natural.  
 2-15-52 Dumped 932 qts. SNG - 3048-3125'. Tamped with 5' pea gravel and 95' Cal-Seal. Shot exploded O.K. Cleaned out to 3083 and well unloaded. Gas measured 555 MCF after 12 hours.
