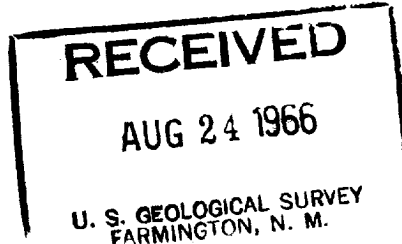

## Instructions
