Marathon Oil Company is requesting to T&A this well. The well has recompleation potential. Marathon is currently evaluating their properties in the San Juan Basin. The shallower horizons are expected to be completed next year. Work performed to T&A the well is shown below.

(Nov 17, 2000): MIRU PU. Could not unseat pump. Backed off rods. POOH w/ rods. Laying down. ND wellhead & NU BOP. SOOH w/ rods & tubing. TIH w/ bit and scrapper to 2950'. POOH.

(Nov 21, 2000): TIH w/ CIBP and set at 2940'. Lay down 1 jt. Circulate 2% KCl w/ corrosion inhibitor. Test CIBP to 500 psi for 30 minutes. POOH w/ 8 stands, standing back. POOH w/ tubing, laying down. TIH w/ 8 stands. ND BOP & NU wellhead. RDMO PU.
