Second Plug- 50' inside of the 5-1/2" casing and 50' above where casing is shot in two

Third Plug - (1585' - 1735') 150' plug extending downward from above the Fruitland coal section across the Pictured Cliffs Sand

Fourth Plug- (900' - 1000') 100' plug extending from 50' above to 50' below the bottom of the Ojo Alamo Sand

10 sacks of cement in top of surface casing with dry hole marker
