Drill 12 1/4" Hole to 315' & set 8 5/8" 24# J-55 ST&C Casing at 310' with 100 sacks cmt. - cmt. circulated to surface - WOC 24 hrs. & test csg. to 800# for 30 min. Drill 7 7/8" hole from base of surface pipe to 5175' & set 5 1/2" 14# J-55 ST&C. The csg. was cemented with 150 sacks pozmix. Top of cement by survey 4330' - WOC 48 hrs. test csg. to 1000# for 30 min.
