Upon receipt of Form C-110 effecting this change, we changed our records to show the operator of the well as James V. Reynolds. That is all that is necessary so far as our regulations are concerned. As the well is on Federal land and covered by Federal bond, the Commission cannot make any statements as to the liability of the bond. 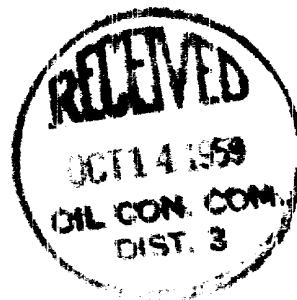
Gentlemen:

I am enclosing copy of \$5,000 oil and gas lease bond filed today with the Bureau of Land Management in the name of James V. Reynolds to cover the Weaver Federal No. 1 well located in NW 1/4 of Sect. 15 - 25N R11W. September allowable No. 61, October allowable No. 5. During September and October this well has been operated under the names of James V. Reynolds and Otto V. Reynolds under a joint blanket bond in the sum of \$10,000. This bond was originally intended to cover the joint operations of James V. Reynolds and Otto V. Reynolds on the Hare lease near Bloomfield. I have sold my interest in the Hare lease to Otto V. Reynolds who has obtained a new bond in his name. My only operation will be on the Weaver Federal No. 1 which is now covered by the new bond. If it is acceptable to the commission I would like to change the name of the operator of Weaver Federal No. 1 from James V. Reynolds and Otto V. Reynolds to James V. Reynolds and I would like a letter from the commission terminating any liability under the joint blanket bond of James V. Reynolds and Otto V. Reynolds which has been replaced by new individual bonds by each party.
