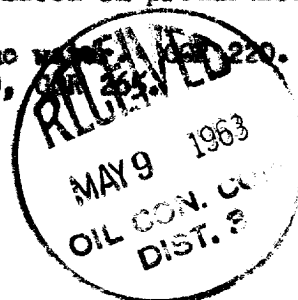

DETAILS OF WORK

- 4-19 Refrac with 1000 barrels oil, 40,000 lbs. 20-40 sand. Maximum pressure 2600 psi. Average injection rate 31 barrels per minute. Flushed with 100 barrels oil. Ran tubing with a Baker anchor catcher and set at 4701' with pump suction at 4764'. Ran pump and rods. Placed on production.
- 4-20 thru Recovered load oil at average 100 B/D rate, no water, 1000 gal 220.
- 5-1 New IP 5-1-63 113 B/D oil, no water, 30 MCF/D, 264.
