Perf 4-1/2" holes at 500'. Ran tubing to 4835' and squeezed 20 sacks cement. Pulled tubing to 500' and pumped 20 sacks cement into perfs, leaving 50' in casing. Filled top 60' with cement and set abandonment marker 10-29-64.
