Central Resources, Inc. plans to plug and abandon the subject well as follows:

- 1) Plug will be set from the bottom perforation (1130') to the surface (103.1 cuft) by mixing and pumping 94 sks (108.1 cuft) of Class B neat cement.
- 2) After cement has set up, tag top and refill hole, if necessary.
- 3) Run 1" pipe down casing anulus to 157' and fill annulus with 34 sks (39.1 cuft) cement.
- 4) Cut off wellhead and install a regulation dry hole marker.
- 5) Rehabilitate location as per BLM regulations.
