It is intended to deepen, case and refrac this well as follows:

- MIRU. TOH and lay down 1" tubing.
- TIH with bit and deepen well to 2350'.
- Run 3 1/2 9.3# tubing set at 2350'. Cement to surface.
- Selectively perforate and fracture treat PC.
- Clean out to PBTD. Land 1 1/2" tubing at bottom perf. Return to production
