12/9/94 Set 165 sack (194.7 cuft) cement plug from 1466' to surface.
Pressured up to 1000 psi. Shut well in.

12/30/94 Installed regulation dry hole marker and cleaned location.

Note: Cement was Class "B" cement mixed at 15.8 ppg, 1.18 cuft/sk yield.

Casing remaining in hole:

Surface casing: 7", 20#, J-55 to 127'

Production casing: 4-1/2", 9.5#, J-55 to 1649'
