This well was spudded November 9, 1992. Drilled 8-3/4" hole to 127'. Ran 3 jts. (123.65') 7", 20#, J-55, 8rd, ST&C casing. Casing set at 124.15'. Mixed and pumped 60 sks. (70.8 cu ft.) Class "B" cement containing 2% CaCl₂ and 1/4#/sk cellophane flakes. Circulated cement to surface. Pressure tested to 600 psi for 30 minutes; test okay.
