It is intended to drill & ~~comple~~ complete a well in the Dakota formation & Mesa Verde formation. Mud circulation will be used thru the Pictured Cliffs & set intermediate casing. Gas circulation will be used thru the middle of the Greenhorn formation & 7" liner will be set. Mud circulation will be used thru the Dakota formation & production liner will be set. Possible productive intervals will be perforated & fractured. Est. T. D. 7825'.

- 5 7/8" at 3400' w/200 sks. cement circulated to surface.
- 7" at 7385' w/800 sks. cement.
- 5" at 7825' w/100 sks. cement.

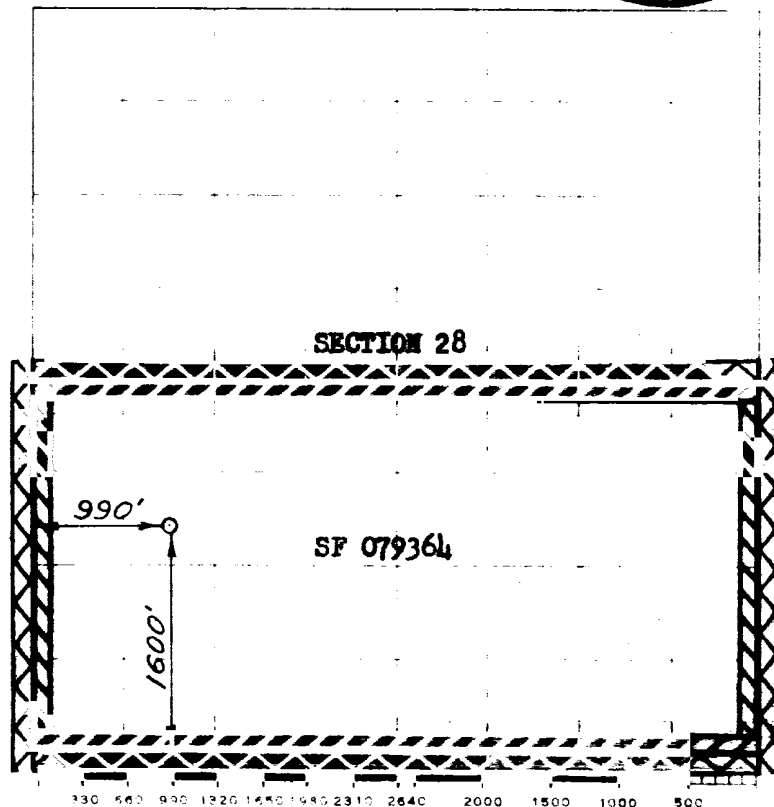
