Plugging procedure is as follows:

- 1) Rig up and break circulation with 1 1/4" tubing in well. Spot 20 sacks cement plug to fill up to depth of 2505' which is 880' above perfs. W.O.C.
- 2) Tag cement and break circulation and spot 10 sacks cement plug from 1412' to 932'.
- 3) Pull tubing, perforate casing at 160' and circulate cement to surface inside and out with 60 sacks cement.
- 4) Set dry hole marker.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
