On 8-25-68 spudded well, drilled surface hole and ran 6 joints 9 5/8", 32.3#, H-40 casing (186') set at 205' w/145 sacks of cement circulated to surface. W.O.C. 12 hours, tested w/600#/30 Min. O. K.

On 8-31-68 T.D. 3960', ran 123 joints 7", 20#, J-55 casing (3948') set at 3960' w/130 sacks of cement. W.O.C. 12 hours, tested w/800#/30 Min. O. K.

On 9-8-68 T.D. 8204', ran 255 joints 4 1/2", 11.6 & 10.5#, J-55 casing (8194') set at 8204' w/395 sacks of cement. W.O.C. 18 hours.

On 9-10-68 F.B.T.D. 8186', tested casing to 4000# O. K. Spotted 300 gal. 7 1/2% HCL. Perf. 7970-90', 8080-95', 8132-47', 8160-75' w/25 SPZ. Frac w/65,000# 40/60 sand, 65,790 gal. water. Max. pr. 4000#, BDF 2100#, tr. pr. 3400-3650-4000#. I.R. 42 BPM. Dropped 3 sets of 25 balls, flushed w/5600 gal. water. ISIF 2100#, 5 Min. 1800#, 15 Min. 1600#, 30 Min. 1450#.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations.
