Gentlemen:

Turner Production Company respectfully requests approval of a location for its proposed Turner 21 #1 well to be located 2390' FSL and 790' FEL of section 21, Township 26 North, Range 7 West as a South Blanco-Pictured Cliffs Pool extension in Rio Arriba County, New Mexico, because of topographical conditions.

The drill tract comprises the southeast quarter (SE/4) of section 21.

Any standard location would be approximately 400 feet above the canyon floor and approximately 200 feet below the mesa top. There is not room to build a roadway along the cliff from the well to the north.

Enclosed is a portion of the USGS topographic quadrangle (Nageezi) for the area. Also enclosed are a copy of the surveyor's plat and an ownership map.


