It is our intention to drill Well No. 1 to approximately 5350' to test the Gallup formation. Our casing program is as follows:

425' of 10-3/4" OD 32.75# casing, cemented with 400 sacks regular cement, to be circulated,

5350' of 5 1/2" OD 14# casing, to be cemented with 200 sacks cement.

The designated drilling unit is the NE 1/4 - SE 1/4 of Section 11-24N-12W, San Juan County, New Mexico.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

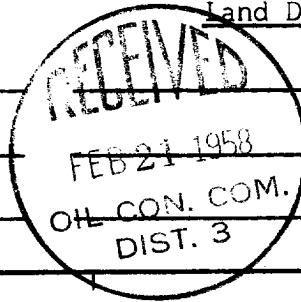

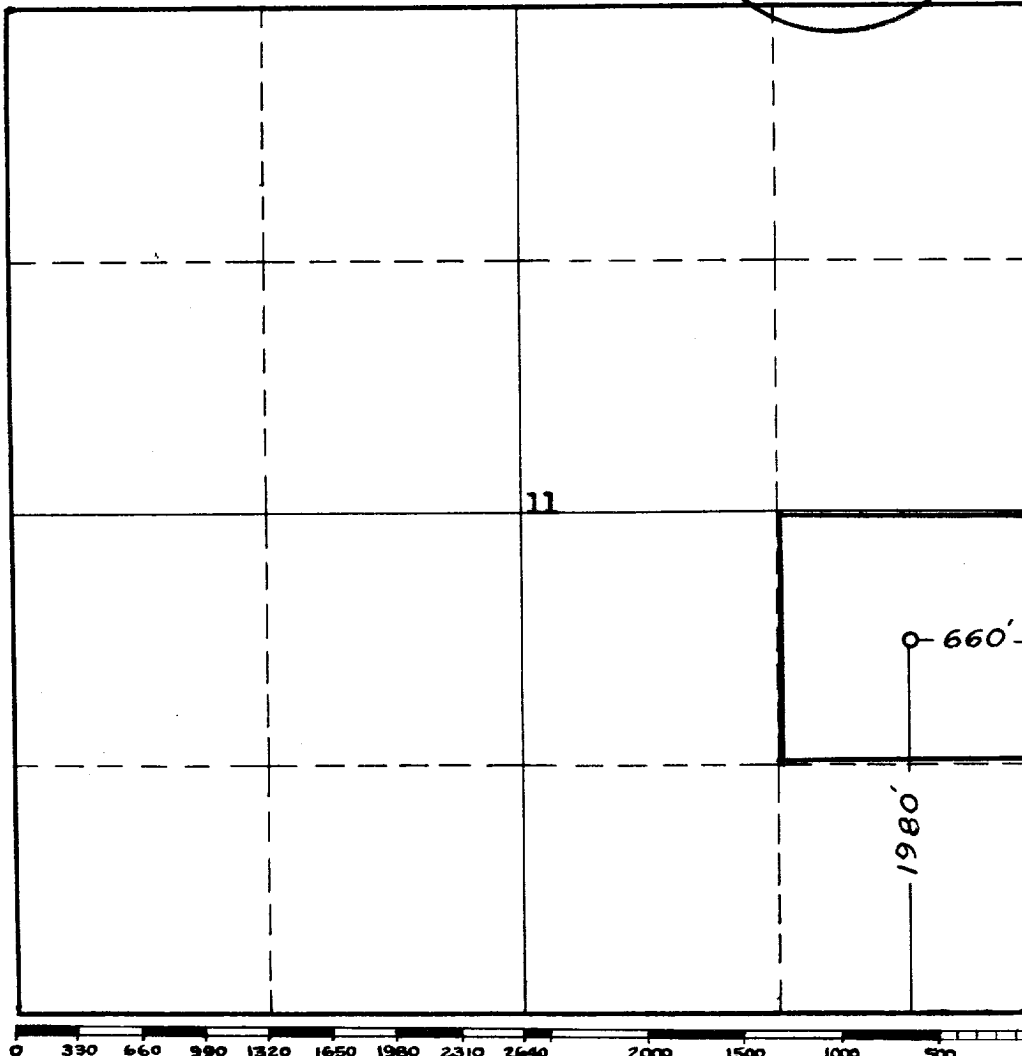
