The designated drilling unit is the N/2-NE/4 of Section 11-26N-12W, San Juan County, New Mexico.

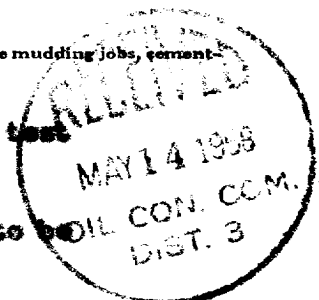

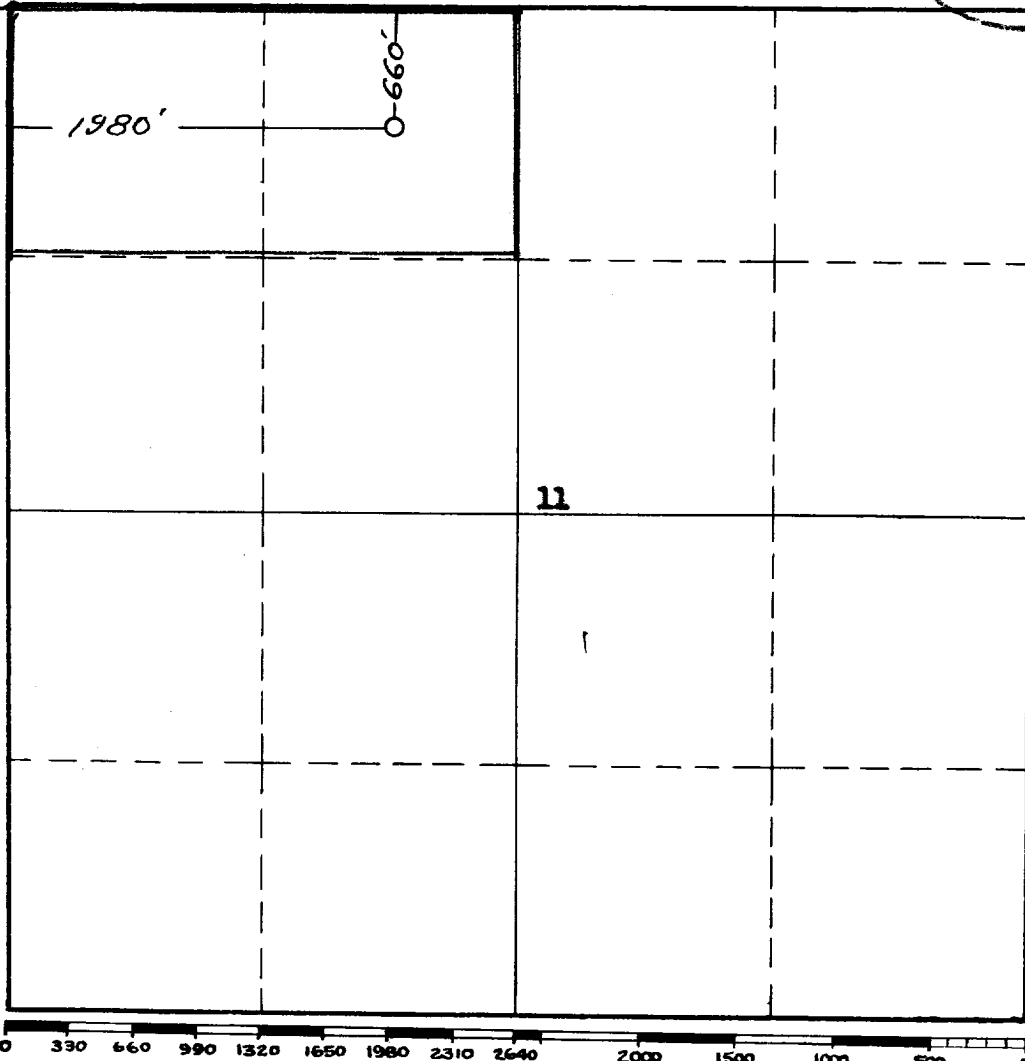
