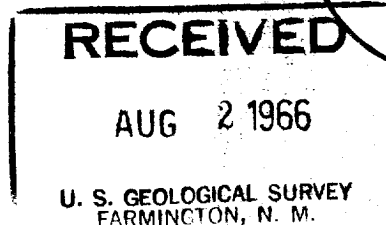
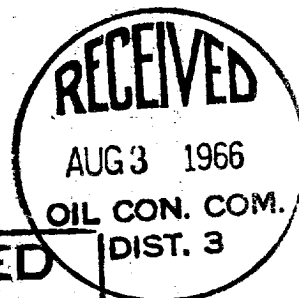

Instructions
