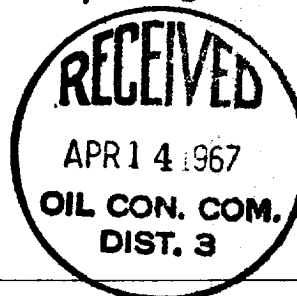

On 3-20-67 spudded well, drilled surface hole and ran 6 joints 8 5/8", 24", J-55 casing (195') set at 207' w/170 sacks cement circulated to surface. W.O.C. 12 hours, tested w/600#/30 minutes O. K.

On 4-1-67 total depth 6736'. Ran 206 joints 4 1/2", 10.5", J-55 casing (6725') set at 6736'. Float collar at 6735', second stage tool at 4818', third stage tool at 2284'. Cemented first stage w/270 sacks cement, second stage w/155 sacks cement, third stage w/165 sacks cement. W.O.C. until completion rig moves on location.

On 4-4-67 P.B.T.D. 6718'. Tested casing to 4000# O. K. Spotted 250 gallons 7 1/2% regular acid. Perf. Dakota 6472-68, 6498-6504, 6558-70' w/18 SPZ. Frac w/40,000# 40/60 sand, 49,980 gallons water. Max. pr. 4000#, BHP 3150#, tr. pr. 3700-3900-4000#. I.R. 36 BPM. Dropped 2 sets of 18 balls each, flushed w/4620 gallons water. ISIP 2400#, 15 Min. SIP 1800#.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
