On 7-27-68 T.D. 2238'. Ran 70 joints 2 7/8", 6.4#, J-55 casing (2228') set at 2238' w/170 sacks cement. W.O.C.

On 8-2-68 P.B.T.D. 2227', tested casing to 4000# O. K. Perf. 2177-87', 2154-64', 2134-44' w/20 SPZ. Frac w/38,000# 10/20 sand, 37,422 gal. water. Max. pr. 4000#, BDP 1300#, tr. pr. 2400-3000-3300#. IR. 24.8 BPM. Dropped 2 sets of 20 balls, flushed w/546 gal. water. ISIP 500#, 5 Min. -0-, 15 Min. -0-.

Instructions

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
