MIRUSU, NUBOPS. Hook up well head, TIH W/ CMNT RET. and set at 493'. Test flow lines and pump 150 sxs Cl B cmt, squeezed to 500psi. shut down. Sting out of RET. Pump 90' plug on top of RET and reverse out. TOH LD TBG. RU and TIH w/perf gun 4 JSPF, shot at 340'. RU and est. rat @ 2BB1/min. and pump 30BB1s H2O at 2 BPM @ 250psi. no returns. Mix and pump 170sxs CL B cmt down casing, circ out 1.5 BB1s good cmt to pit. BLM REP. on location for entire job. Cut off wellhead and weld on P&A marker. Restore location.

This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special in-

structions concerning the use of this form and the number of copies to be submitted, particularly with regard to local area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.


Reference is made to your well No. 117 San Juan 28-7 Unit, SW $\frac{1}{4}$ SW $\frac{1}{4}$ Sec. 6, T. 27 N., R. 7 W., Rio Arriba County, New Mexico, Lease SF-078835 and your Sundry Notice approved on July 5, 1991. This well has been approved for plugging for over a year. If the well has been plugged, you are required to submit a subsequent report of abandonment. If the well has not been plugged, you are required to inform this office when the work is scheduled to be performed.

You have 30 days to comply with this order. The 30 days commences upon receipt of this letter or seven days from the date it is mailed, whichever is less. Failure to comply within the 30 days will result in strict enforcement of 43 CFR 3163.1.

Under provisions of 43 CFR 3165.3, you may request an Administrative Review of the orders described above. Such request, including all supporting documents, must be filed in writing within 20 business days of receipt of this notice and must be filed with the State Director, Bureau of Land Management, P. O. Box 27115, Santa Fe, New Mexico 87502-0115. Such request shall not result in a suspension of the order(s) unless the reviewing official so determines. Procedures governing appeals from instructions, orders or decisions are contained in 43 CFR 3165.4 and 43 CFR 4.400 *et seq.*
