DETAILS OF WORK

It is proposed to drill with rotary mud to the top of the Mesaverde formation, estimated to be at a depth of 4800', and thereafter to drill with gas through the Mesaverde formation or to the top of the Mancos shale. Final TD estimated to be 5800'- $\frac{1}{2}$ feet. It is further proposed to sand oil frac the entire Mesaverde section. Tentative casing program is as follows:

10-3/4" surface casing 250'
7" casing 4800'
