TD 2978', ran 69 jts of 5 1/2" 15.5# K-55 casing, 2964' set @ 2977' Stage tool @ 2324', marker joint @ 2707', Float collar @ 2934', and cement nose guide shoe @ 2977'. Stage 1. Lead with 60 sks of Class B cement 65/35 Poz, 6% gel, 2% CaCl2, 5# gilsonite/sk, and 1/4# Flocele/sk (106 cu ft.). Tail with 90 sks of Class B cement with 2% CaCl2, (106 cu ft.). Circ. 6 bbls to surface. Stage 2. Lead with 410 sks of Class B cement 65/35 Poz, 6% gel, 2% CaCl2, 5# gilsonite/sk, and 1/4# Flocele/sk, (726 cu ft.). Tail with 60 sacks of Class B cement with 2% CaCl2, (71 cu ft.). Circ. 25 bbls to surface. WOC 12 hours.
