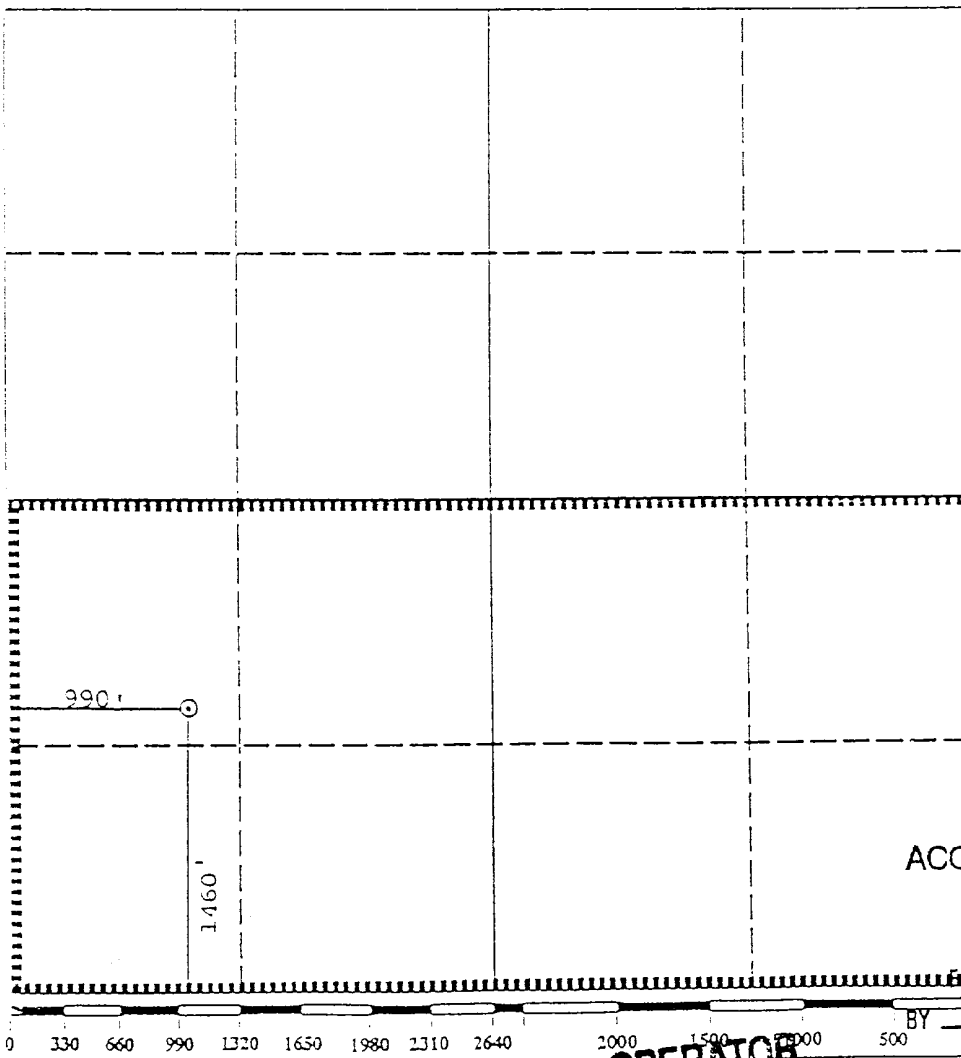

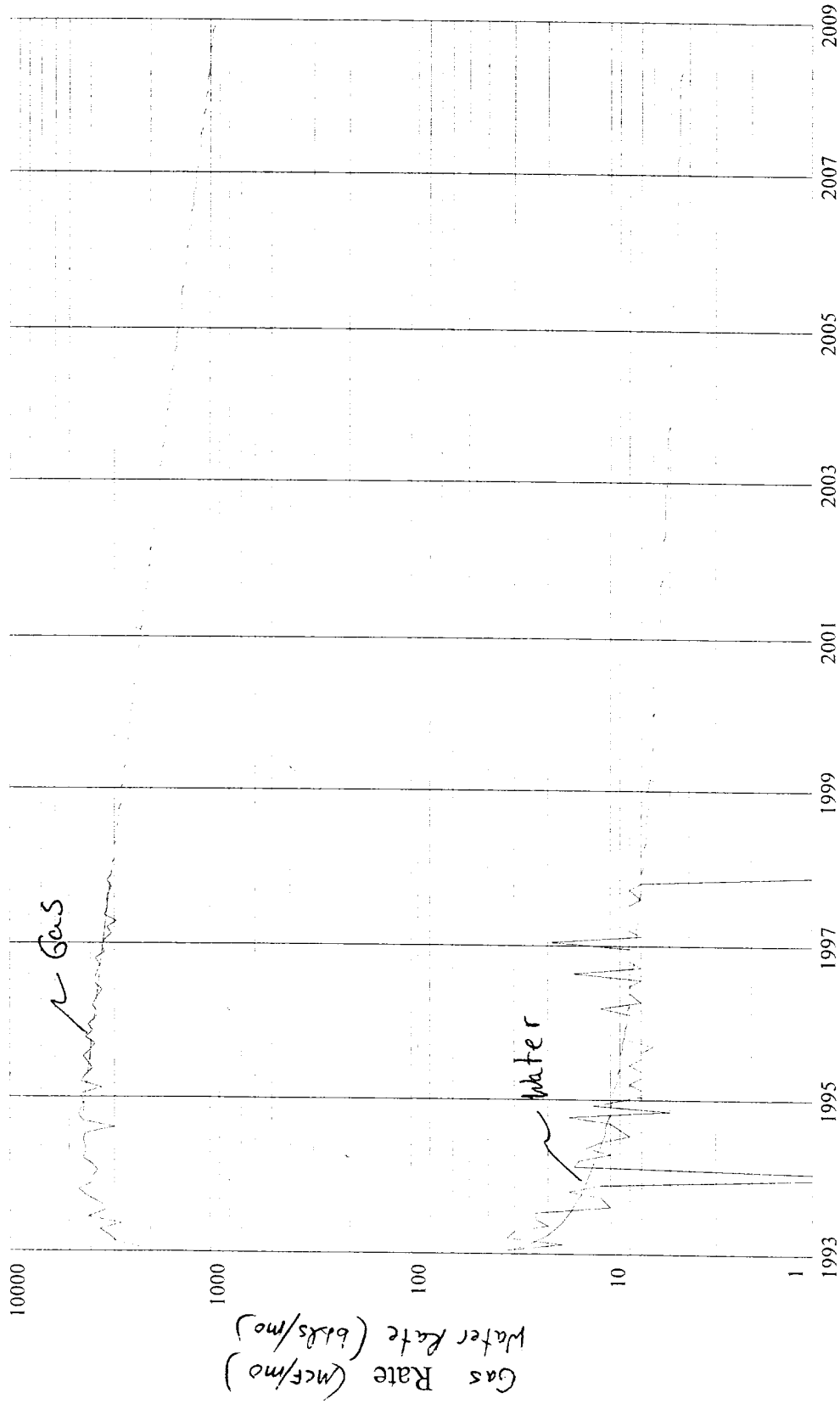
Rate/Time Graph

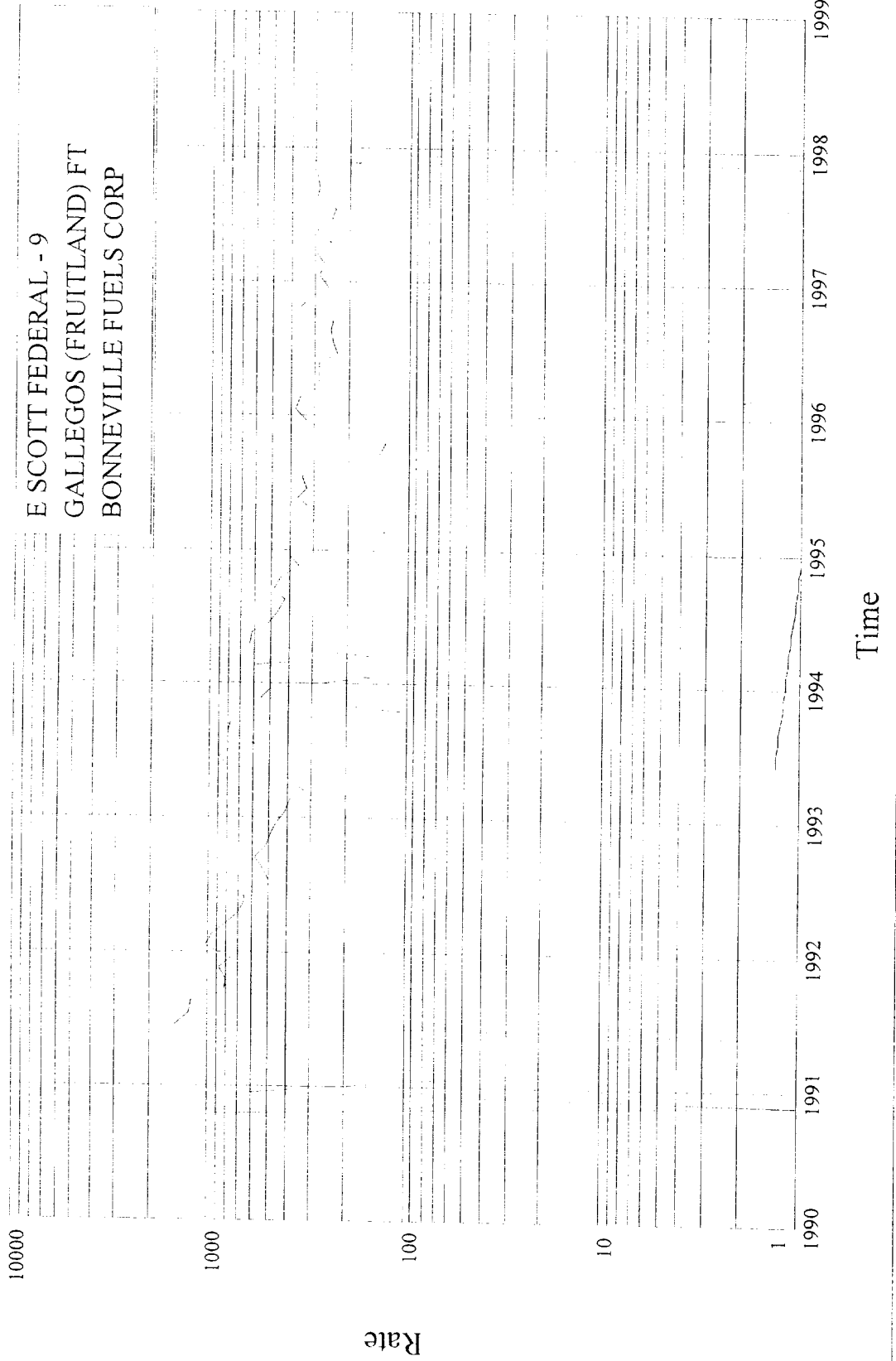
Rate/Time Graph

The allocation formula will be a varying percentage allocation that will change each month based on the gas production forecast for the Fruitland Coal zone and the total measured production from both zones each month.

Gas Allocation

The gas production allocation for the Fullerton Federal #3 will be performed as follows:

1. Production will be allocated monthly to the Basin Fruitland Coal according to a baseline production forecast schedule extrapolated from historical production data (See decline curve and production table).
2. Any gas production over and above the baseline production forecast established for the Basin Fruitland Coal will be attributed to Gallegos Fruitland Sand on a monthly basis. If monthly gas production falls below the baseline forecast for the Basin Fruitland Coal, all production will be attributed to the Basin Fruitland Coal for that month.

Decline curves for both zones are attached. The Fruitland Sand EUR is based on production and reserves for the Scott E. Fed. #9. This well, located in Sec. 23, T27N, R11W is the nearest Fruitland Sand producing offset.

Oil Allocation

Oil production is expected to be negligible. If any oil is produced it will be allocated evenly between the two zones.
