- TOH & LD tbg to 4,937'. Spot a 100' cmt plug across the Gallup formation top fr/4,937'-4,837' w/15 sx cl "B" cmt w/2% CaCl2.
- TOH & LD tbg to 2,150'. RIH & perf 2 sqz holes @ 2,210'.
- PU 5-1/2" cmt retainer. TIH w/cmt retainer & tbg. Set retainer @ 5,800'. Sqz a 30 sx cl "B" cmt plug outside csg & 17 sx cl "B" cmt plug inside the csg across the Cliff House formation top fr/2,210'-2,110'.
- TOH & LD tbg to 1,320'. Spot a 330' cmt plug across the Fruitland Coal & Pictured Cliffs formation tops fr/1,310'-980' w/55 sx cl "B" cmt. Note: The csg was perf'd @ 1,350' and 1,120' and squeezed with 525 and 162 sx of cmt respectively during last csg repair.
- TOH & LD tbg. RIH & perf 2 sqz holes @ 299'.
- Establish circ to surf. Circ 100 sx cl "B" cmt.
- Cut off & install P&A marker. Cmt marker with 10 sx cmt.
