2. TIH & tag fill @ 6,423'.
3. Set RBP @ 6,194'. Press tested RBP to 1,000 psig.
4. Isolated casing leak from 524' - 539'. EIR @ 3 BPM & 100 psig.
5. Squeezed leak with 290 sx Class "B" cement.
6. Circ cement to surface. WOC over weekend.
7. Drilled out cement & pressure tested casing to 500 psig, held OK.
8. TIH w/prod tbg & RWTP.
