- 3) RIH w/bit & DC's on 2 3/8" tbg. DO to 1895'.
- 4) Circ hole clean & press test pipe to 2500 psig & POOH.
- 5) RU Loggers. Ran GR-CCL-CBL bond across zone of interest.
- 6) Perf'd Fruitland 1818'-21', 1849'-58', 1876'-83', with 2 JSPF on September 25, 1990
- 7) RIH w/FB packer on 2 3/8" tbg.
- 8) Acidize perfs w/1500 gals 15% NEFE & 60 ball sealers @ 3 BPM @ 1500 psig.
- 9) Released pkr & knock off balls & POOH.
- 10) Frac'd formation w/65,000# sand x 42,500 gals 70 quality nitrogen foam @ 15.5 BPM @ 1200 psig.
- 11) Flow well to frac tank.
