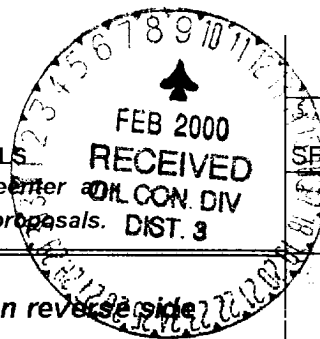

Bonneville Fuels proposes to re-complete the Upper Fruitland Coal formation in the above reference well following the procedure listed below: (1) MI RU & kill well w 2% KCL if necessary. (2). Tag PBTD, TOOH w/ 2 3/8" production string (3) Perforate Fruitland Coal formation 1530'-1533'; 1567'-1571'; 1577'-1580'; 1585'-1587'; 1617'-1620'; 1624'-1626'; 1687'-1689' (total 19') w/4 jsp. TIH with packer & acidize each zone with 200 gal 7 1/2% HCL acid, total of 1400 gal. Flush w/ 2% KCL water. Pull packer & RIH w/ 1 1/2" production tubing landed at +/- 1760'. Return well to production, down hole comingled with pictured cliffs formation. Work estimated to commence 3/2000.
