Bradenhead would build pressure.

12/04/00 to 12/05/00 MIRU pulling unit. Set RBP at 2,530'. Isolated casing leak between 120'-187'. Pumped water into casing leak 1.5 BPM at 800 psig and circulated to surface out bradenhead valve. Got verbal permission from Steve Hayden with NMOC at 9:30 a.m. on 12/05/00 and Stephen Mason with the BLM at 10:30 a.m. on 12/05/00 to squeeze cement casing leak.

Proposed procedure.

1. RIH with packer on 1 jt tubing. Set packer at 30'.
2. Open bradenhead valve. Start pumping water down casing. Break circulation to surface with water.
3. Switch to cement. Pump 50 - 100 sx Type III cement + 3% CaCl<sub>2</sub>. Circulate cement to surface. Close bradenhead valve and squeeze leak.
4. TOH with packer. Shut well in. Wait on cement to set.
5. Drill out cement. Pressure test casing.
6. Pull RBP at 2,530'. TIH with production tubing. Return well to production.
