TIH & set CIBP @ 2350'. Run Bond log in 5 1/2" CSG to determine CMT top. PU above CMT top & run bond log inside 7" CSG. Depending on CMT top SQZ bradenhead leak. DO SQZ & pressure test CSG to 500 psi. Put well back on production.
