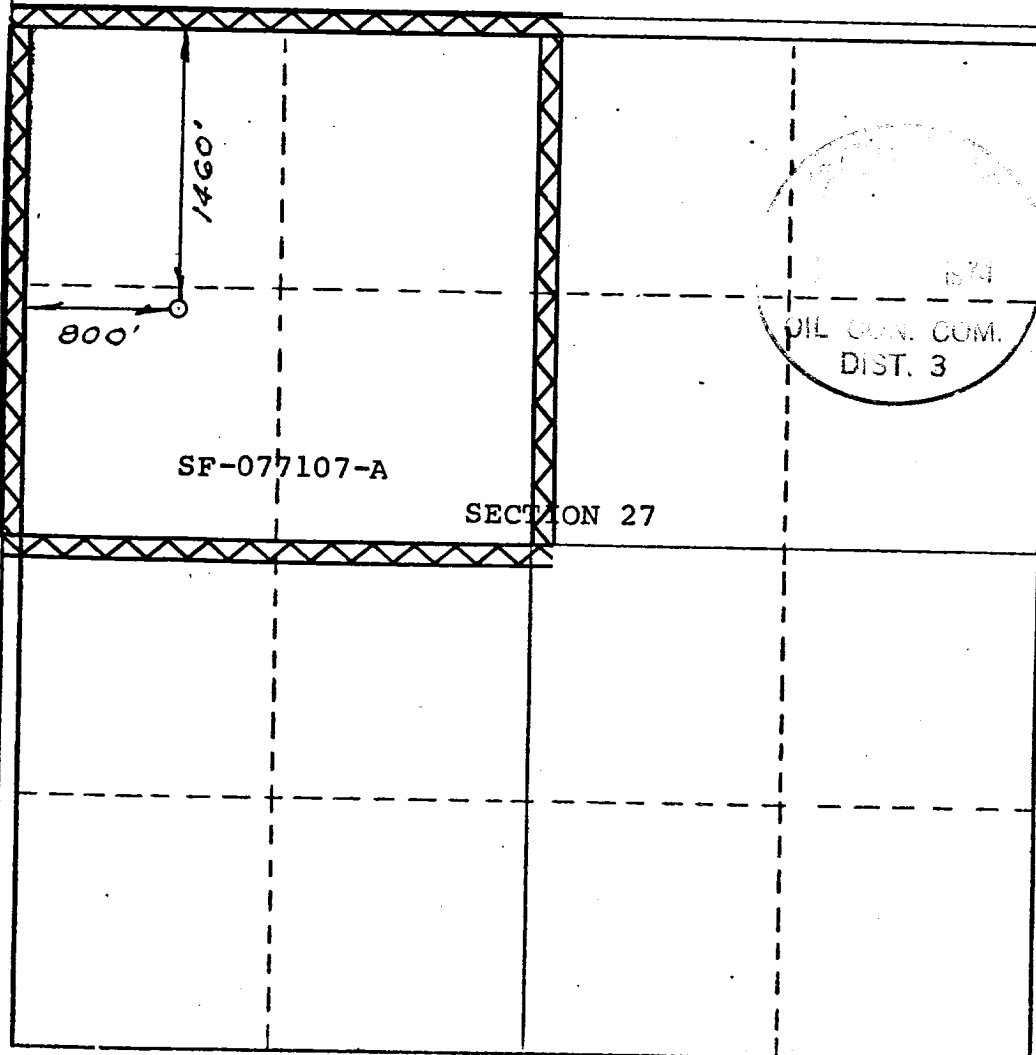

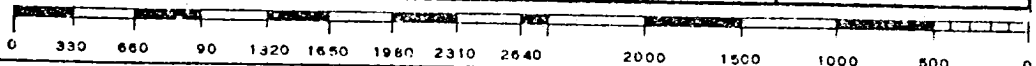

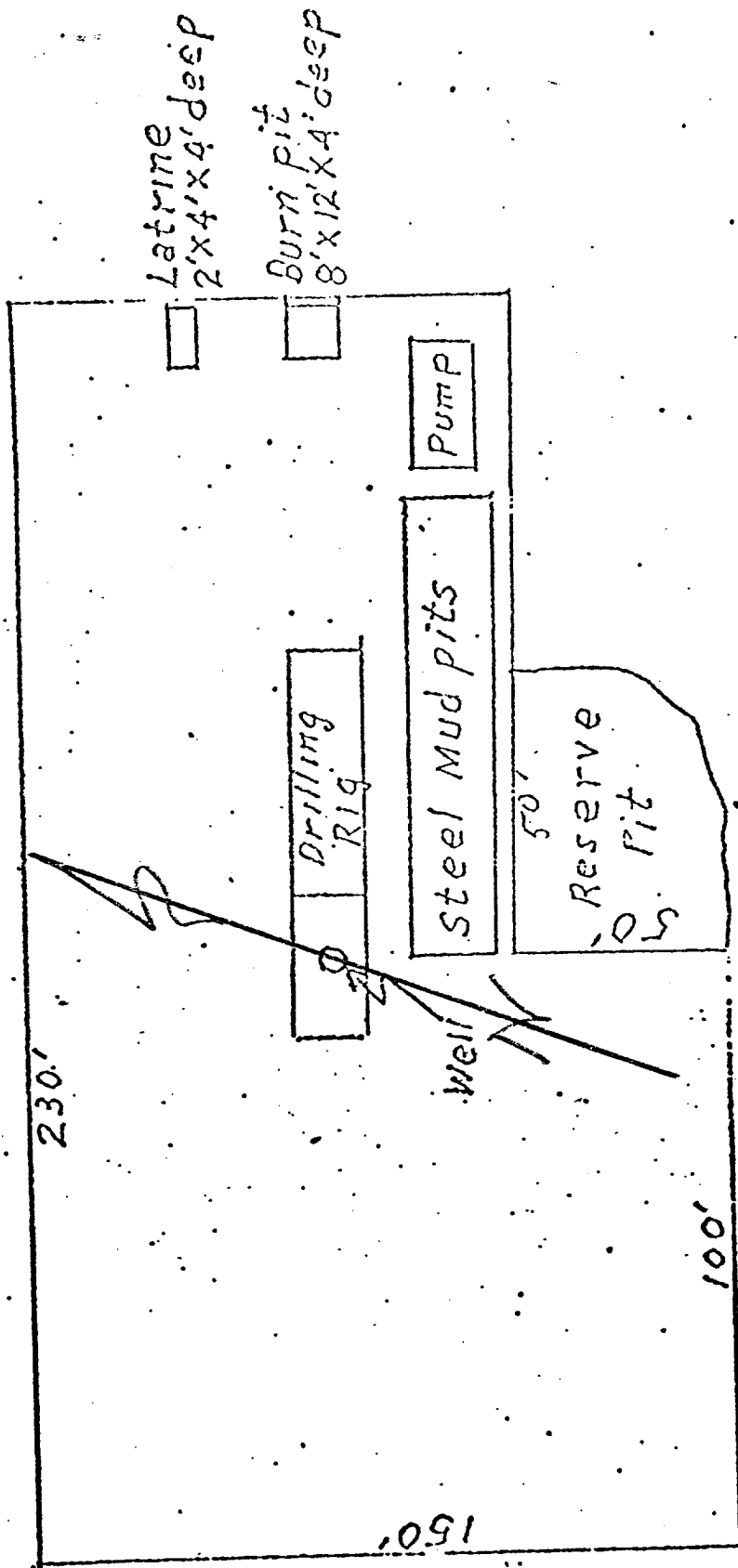

HANCOCK "B" No. 11



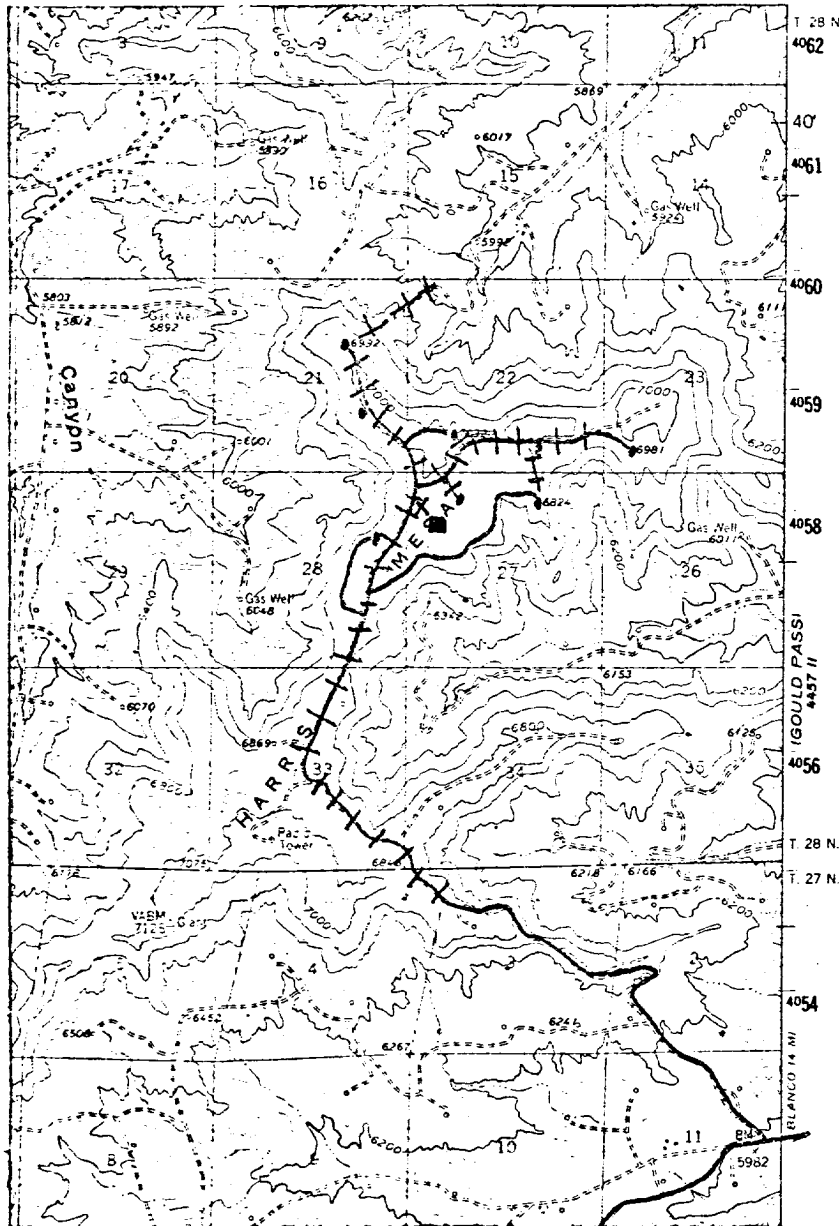
