05/29/01: Install permanent dry hole marker on well by placing piece of 20" casing around wellhead. Set dry hole marker on casing head flange. Filled annulus between 20" and wellhead with 8 sacks (4.0 cf) of Quikrete. Let cement cure. Removed pit fence and back fill pit and bell hole around 20" casing.

07/10/01: Rip location surface and access road. Seed road and location with 18 1/2 lbs. (2 lb/acre) seed mix # 2. Construct drainage/traffic diversion berms on both ends of access road.

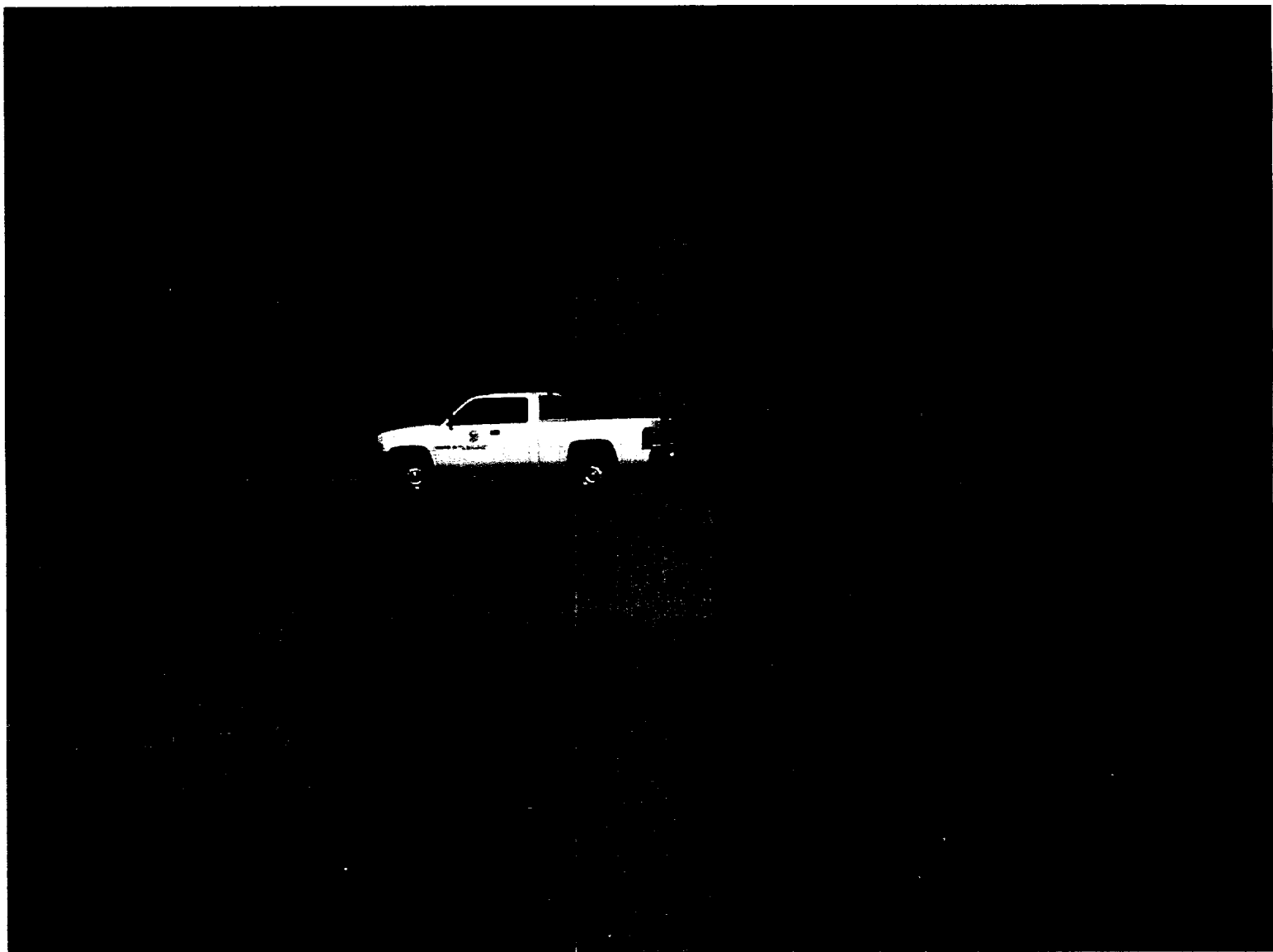

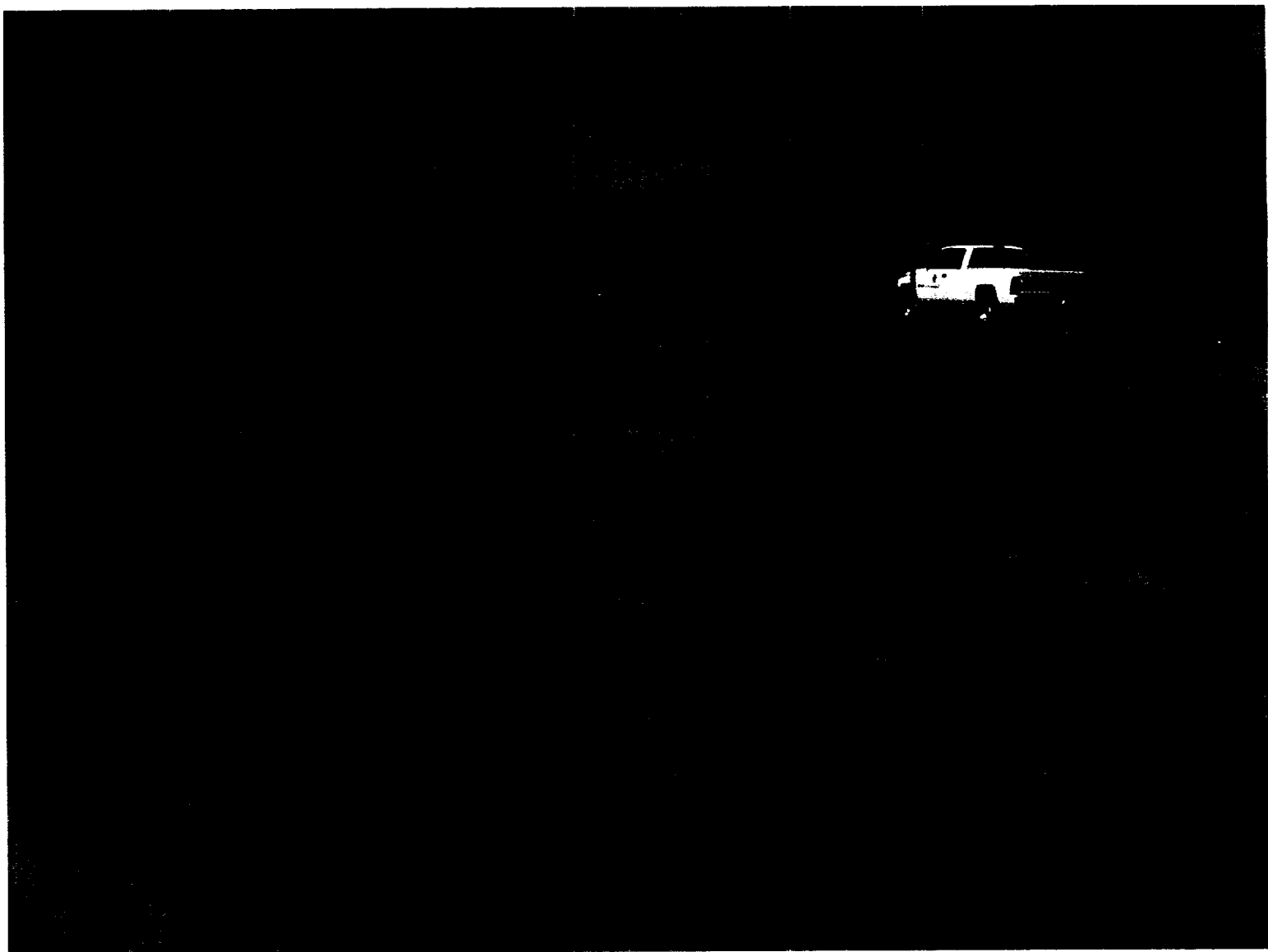
