3. Ran 5 joints of 7-5/8", 29.70#, C-75 casing and set at 219 ft. R.K.B.
4. Cemented with 125 sacks of class "B" with 3% calcium chloride. Plug down at 7:30 a.m. 3-13-81. Cement circulated to surface.
5. Waited on cement for 12 hours.
6. Pressure-tested casing to 900 P.S.I. for 15 minutes. Held OK.
