TIH, tag cmt @ 1596'. PUH to 1025'. Attempt to PT csg, pump 4 bbls wtr, got returns out bradenhead. Mix & pump 76 sx Class B cmt. TOO. WOC. SDON.  
(9-21-01) Verbal approval from Steve Mason & Mike Wade, BLM, to TIH w/tbg to 373' & fill 7-5/8" csg to surf. TIH w/tbg, tag cmt @ 704'. PUH to 373', close in bradenhead, PT csg to 500 psi, bled to 400 psi in 10 mins. Mix & pump 107 sx cmt, circ 1 bbl good cmt to surface. TOO. Mix and pump 17 sx cmt w/2% calcium chloride, down csg, close all csg valves, press to 400 psi. SI & WOC. Bled down press on WH. ND BOP. Dig out & cut off WH, cmt fell 15'. Install P&A marker & fill csg w/10 sx cmt. RD. Rig released. Mike Wade, BLM, on location. Well plugged and abandoned 9-21-01.
