Attached in duplicate (to each office) are a well location plat (C-102) with an ownership plat for the above referenced well.

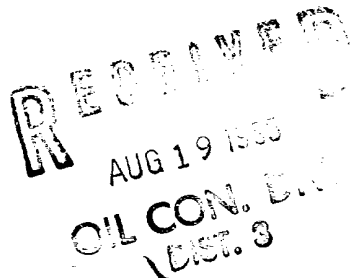
Due to an archaeological site and a steep hill to the south, this location does not meet state spacing requirements. This is the only geologic and topographic site acceptable.

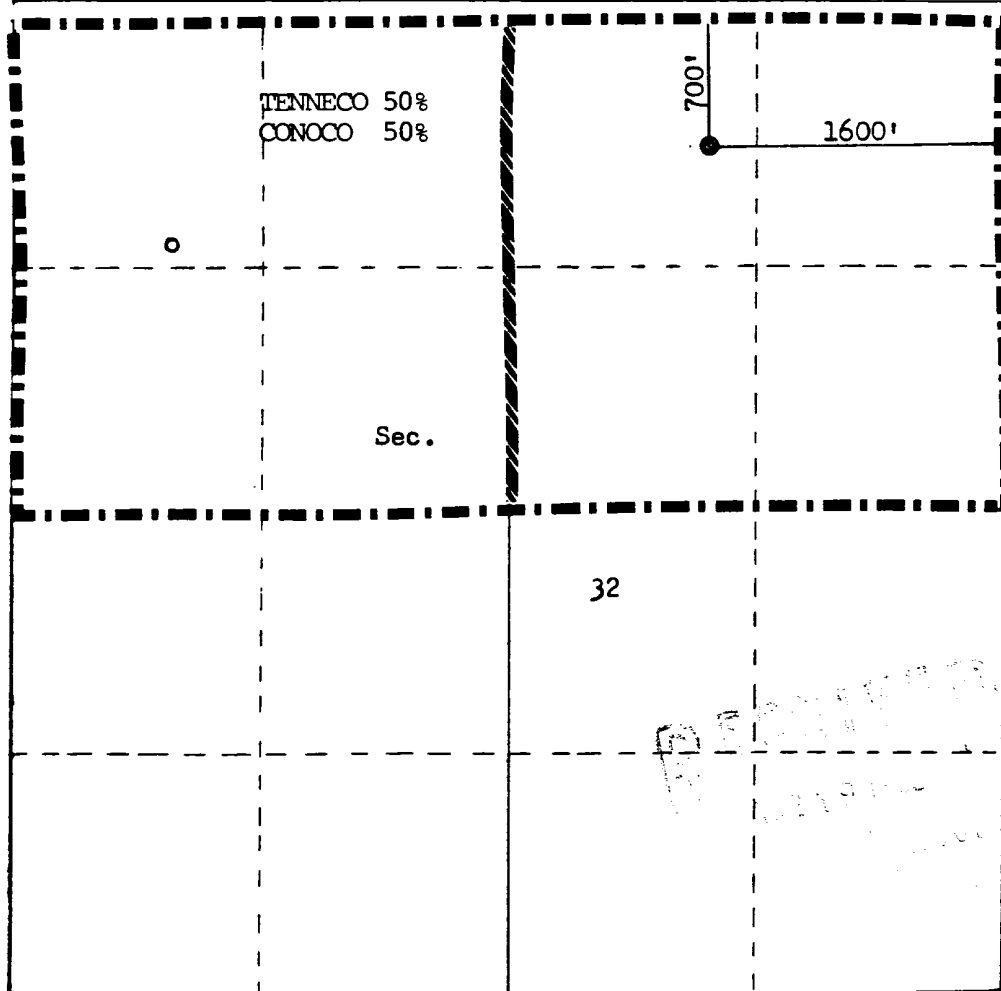

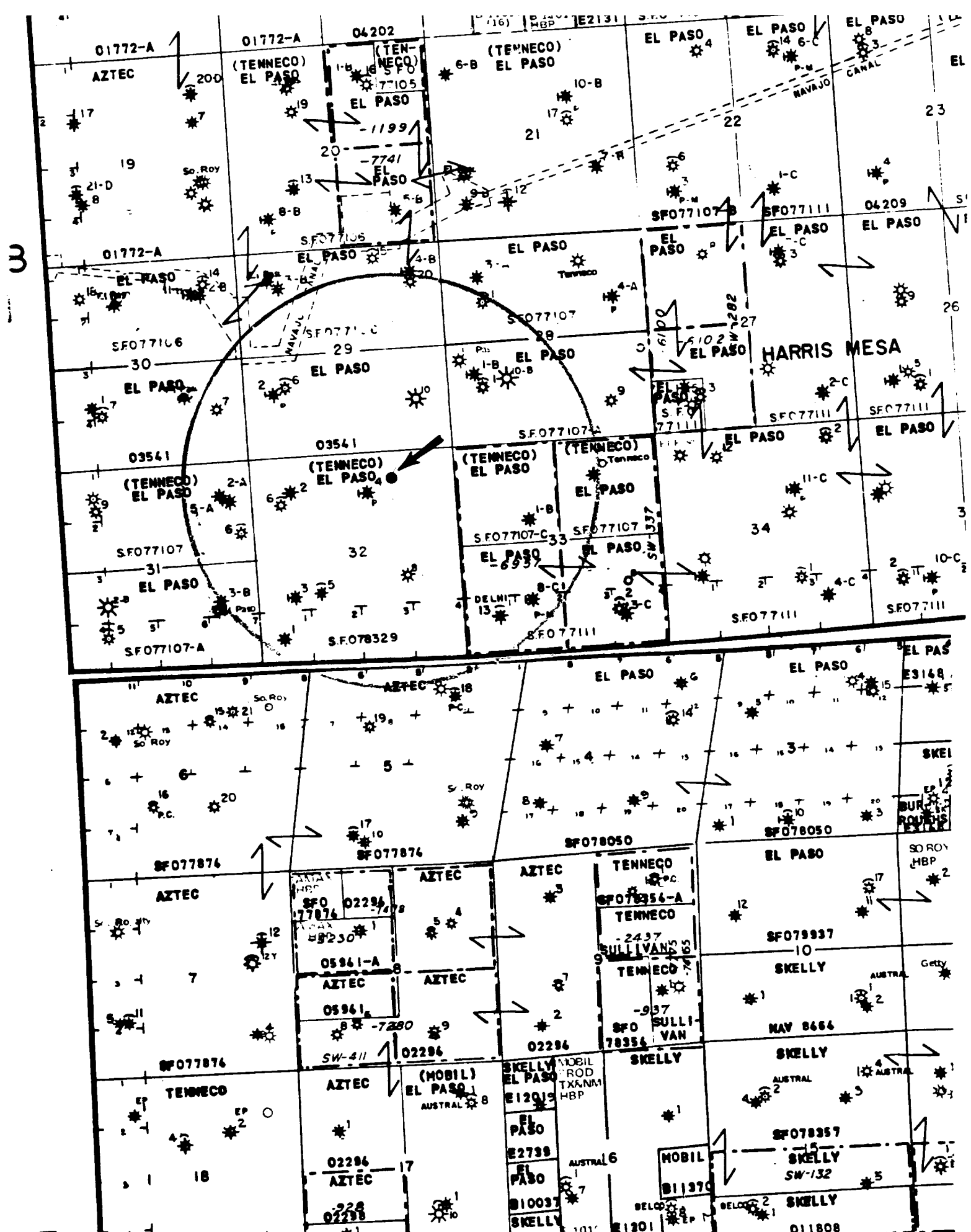

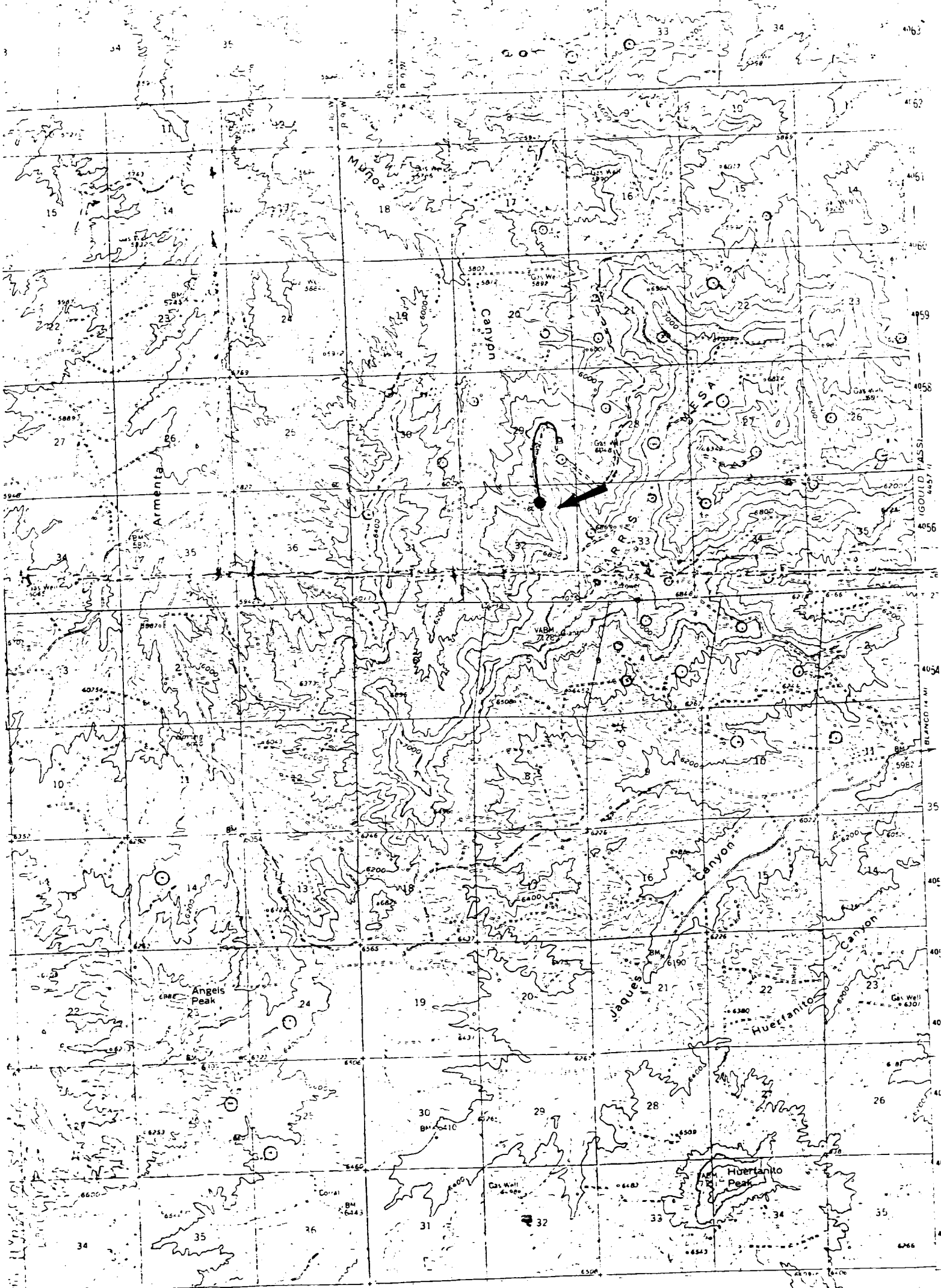
